7. Proclamations:

a. Child Abuse Prevention Month

WHEREAS: Children are critical to Banks County's future success, prosperity, and quality of life, Children are our most valuable resource, and they are also our most vulnerable. Our children have a right to be safe and provided the opportunity to thrive,

WHEREAS: Childhood is precious. Growing up in a loving home, with a nurturing family, surrounded by a safe community gives our children the best opportunity to realize their full potential. Sadly, mistreatment by parents and caregivers can threaten a child's sense of worth and hinder their success in the home, in the classroom, as a future member of the workplace and in future relationships; and

WHEREAS: Child abuse and neglect can be prevented by supporting and strengthening our families, thus preventing the far-reaching effects of maltreatment and providing the opportunity for children to develop healthy, trusting family bonds and consequently, building the foundations of the community; and

WHEREAS: Effectively intervening in the lives of children affected by abuse is a shared community responsibility. Child abuse prevention activities succeed because of the meaningful connections and partnerships created between child welfare, education, health community, faith-based organizations, businesses and law enforcement agencies. The Banks County Department of Family and Children Services, Banks County Family Connection, Piedmont CASA, The Tree House, The Banks County School System, and Peace Place are committed to preventing child maltreatment and promoting positive parenting;

WHEREAS: The Banks County Board of Commissioners does hereby proclaim the month of April 2018 as Child Abuse Prevention Month, urging all citizens to recognize this month by dedicating ourselves to the task of improving the quality of life for all children and families.

b. Lifelink National Donate Life Month

County Clerk Regina Gailey presented a proclamation stating,

WHEREAS, one of the most meaningful gifts that a human being can bestow upon another is the Gift of Life; and

WHEREAS, more than 121,000 men, women, and children await life-saving or life-enhancing organ transplants, of which over 5,900 reside in Georgia; and

WHEREAS, the need for organ, eye and tissue donation grows daily as a new patient is added to the national waiting list for an organ transplant every 10 minutes; and

WHEREAS, the critical donor shortage remains a public health crisis as an average of 22 people die daily due to the lack of available organs; and

WHEREAS, organ, eye, and tissue donation can provide families the comfort of knowing the gift of donated organs and tissue endows another person with renewed hope for a healthy life; and

WHEREAS, more than 4.7 million Georgians have already registered their decision to give the Gift of Life at www.donatelifegeorgia.org or when getting or renewing their driver license or state identification card at a driver license office; and

WHEREAS, LifeLink of Georgia is the non-profit, community service organization dedicated to the recovery of high quality organs and tissues for transplantation therapy; and

WHEREAS, Banks County supports the life-saving mission of LifeLink of Georgia; and

NOW, THEREFORE, I, Banks County Commissioners, Banks County do hereby proclaim April 2018 as Donate Life Month.

c. National Telecommunicators Week – April 8 – April 14, 2018

911/EMA Director Deidra Moore stated the week of April 8 – April 14, 2018 had been designated by Governor Deal as Nation TeleCommunicators Week in Georgia. She presented a proclamation to the Commissioners that stated,

Whereas emergencies can occur at any time that require police, fire or emergency medical services; and,

Whereas when an emergency occurs the prompt dispatch from 911 for a prompt response of public safety responders is critical to the protection of life and preservation of property; and,

Whereas the safety of our public safety responders is dependent upon the quality and accuracy of information obtained from citizens by the Banks County E-911 Communications Center; and,

Whereas Public Safety Telecommunicators are the single vital link for our public safety responders by monitoring their activities by radio, providing them information and insuring their safety; and

Whereas Public Safety Telecommunicators of the Banks County have contributed substantially to the apprehension of criminals, suppression of fires and treatment of patients; and

Whereas each Dispatcher has exhibited compassion, understanding and professionalism during the performance of their job in the past year;

Therefore, Be It Resolved that the Banks County Commissioners reaffirm that the week of April 8 through 14, 2018 is recognized as National Public Safety Telecommunicators Week in Banks County, in honor of the men and women whose diligence and professionalism keep our county and citizens safe.

Ms. Moore stated she would like to recognize the dispatchers for the outstanding job they do. She stated they serve selflessly and do a thankless job.

8. Planning Commission Recommendations:

a. Z-18-01 – Randall Cochran – A rezoning application for property located at 2128 Highway 198 Baldwin, GA 30511 from ARR Agricultural Rural Residential to CAD Consolidated Agricultural District.

Frost stated zoning application Z-18-01 – Randall Cochran was for rezoning property located at 2128 Highway 198 Baldwin that is currently zoned ARR Agricultural Rural Residential to CAD Consolidated Agricultural District. Zoning Officer Paul Ruark stated the Planning Commission recommended approval.

Comm. Duckett stated he had spoken with Mr. Cochran and Mr. Cochran had asked Comm. Duckett if he could present the application if possible. Zoning Officer Ruark stated Comm. Duckett could represent the application but he could not vote on the request.

Comm. David Duckett – 4373 Old Hwy 441N, Alto, GA – Represented the application.

Atty. Frost closed the public hearing. Vice Ch. Reece opened the meeting.

b. V-05-02 – Jonathan Gosnell – A variance to reduce the required setbacks for two poultry houses located at map/parcel #B39/068

Vice Ch. Reece closed the meeting. County Attorney Randall Frost opened the public hearing stating V-05-02 was a variance to reduce the required setbacks for two poultry houses. Zoning Officer Paul Ruark stated the Planning Commission recommended denial of the application.

Jonathan Gosnell – 304 Marion Cape Road – Stated he wanted to build two chicken houses at the end of Marion Cape Road and originally was going to move in a double wide trailer but has now decided to build a permanent house to leave in.

Alex Dominquez – 4155 Treadour Bay Lane, Norcross, GA – Stated he opposed the application and he owned a parcel that was adjacent to Mr. Gosnell. He stated he used the land for recreational purposes. He asked the Commissioners to consider that the land and everything on

Marion Cape Drive is restricted against any manufactured homes and homes under a certain square footage and acreage. He stated this area was clearly intended for residential use and he feels a variance granted will be detrimental to his property and greatly impact his property value. He also stated the truck traffic would increase on the well maintained county road and would erode the roadway. He stated he was requesting the Commissioners to consider the Planning Commission denial and that we all follow the good rules that were set in place. Comm. Turk stated Mr. Dominquez property was zoned ARR. Mr. Dominquez stated that he had no opposition of the use but just the setbacks. Vice Ch. Reece stated the setback was 200 feet from the property line and four hundred feet from the nearest house. Mr. Dominquez said the letter he received in the mail stated 400 feet. Comm. Reece stated the letter should have been written as a conditional use instead of a variance. Comm. Maxwell asked Zoning Officer Ruark why a variance was asked for rather than a conditional use. Mr. Ruark stated Mr. Gosnell made an application for a variance. Mr. Ruark stated he was at training the week Mr. Gosnell applied and a variance suited the property better than a conditional use. Mr. Ruark stated he could have applied three different ways, a conditional use, rezone to CAD or ask for a variance. Mr. Ruark stated he wasn't here to tell the applicants what to do but give people the rules and let them do what they see fit. Mr. Gosnell chose to apply for a variance. Vice Ch. Reece stated the Planning Department was set up to help people and for most of the people that come in, it's their first time and they have to have guidance.

George Varzaly – 7471 Shady Glenn Drive, Flowery Branch, GA – Stated he owned 46 acres adjacent to Jonathan Gosnell and the property he owned had restrictions not to build any poultry houses, raise hogs or have dog kennels. He stated right where the 3 properties meet was where Mr. Gosnell wanted to build the poultry houses. Mr. Varzaly stated Mr. Gosnell's father had just cleared 30 acres on the back of the property for pasture land and that would be a much more suitable place to put the poultry houses.

Vice Ch. Reece stated he had visited the property and you could already see 12 chicken houses around the area. Atty. Frost closed the public hearing. Vice Ch. Reece opened the meeting.

11. Hotel/Motel Code Violations

Carlton Speed

Sheriff Carlton Speed stated he would also like to thank the 911 dispatchers for the job each one of them do.

Sheriff Speed stated he was there to talk about a business in the County that has become a haven for illegal activity and a place where families are staying for months at a time. He said he was talking about the Scottish Inn at Banks Crossing. The resources Banks County extends on the establishment was very detrimental to our community as a whole. Some instances the Sheriff's Office had handled at the Scottish Inn were drug dealing, domestic disputes, and stabbings. He stated he came tonight not only as the Sheriff, but as a Taxpaying Citizen of Banks County asking the Commissioners to start looking at some things we can do to change that establishment and how they do business.

Katrina Willis, Investigator presented charts and graphs showing the resources that are spent at the Scottish Inn. There were more EMS calls, arrest warrants served, sex offender registry checks, civil papers served and suspicious activity calls than any other hotel in the area.

Lieutenant Scott Crane currently working at the Banks County Sheriff's Office was in Code Enforcement before working at Banks County and was also a State Fire Marshal and an Arson Investigator stated Banks County had passed an ordinance about hotels and extended stay. It was passed in June 2017 and will take in effect June 2018. Lt. Crane stated by just doing a walk-thru inspection there were many safety violations and those violations could cause a loss of life if not corrected.

Sheriff Speed stated he was asking for the County to come together as a group and see what could be done about the establishment and what can be done to get them up to code.

The Commissioners stated they would get together and help resolve the problem.

12. Diana Food Pretreatment Facility Cost Overrun
