c. Planning/Zoning: Clarification on Board of Commissioners ability to grant hardship requests for financial and/or medical purposes. Kerri Fincannon

Ms. Fincannon stated they were looking at adding a definition to zoning called a Hardship Lenience. She stated she didn't use the word variance. The definition is a relaxation or a modification of the regulations of this code as applied to a specific property when because of extreme financial or medical emergency compliance result in a particular hardship upon the owner. She further stated there would be a section added that further defines it this way. The governing body is hereby empowered to authorize upon application and on a case-by-case basis as a special exception and without the provisions of a public hearing, a lenient to the restrictions of the code to alleviate the hardships incurred by extreme financial or medical emergencies. Relief, if granted will not be injurious to the neighborhood or the health or general welfare of the public in such a manner as will interfere with or discourage the appropriate development and use of other property or unreasonably affect its value. The lenients requested shall be the minimum variance that will relieve the strain of the emergency. Relief may be granted as temporary in nature and subject to any conditions that may be deemed appropriate to the furture use of the property.

Comm. Ausburn stated that there would have to be clear cut definitions of financial hardships.

Ch. Turk stated that if we can't help people that are in a hardship then we shouldn't be here.
